Accordingly, we would wish to explore with you what alternative funding might be available, CIL for instance. The footpath was originally installed by the City Council using 'scalpings'. Time, and the activities of GigaClear installing fibre-optic cables, have rendered the path very uneven, lacking drainage and unusable in places. The issue has been exacerbated by the closure of the Permissive Footpath across the SSSI into the Wansford Quarter of Sulehay Woods requiring all walkers to use the footpath at the junction of the Old Leicester Road and the King's Cliffe Road. This is a dangerous blind corner with much daily high-speed traffic. 2000 vehicles a day are logged routinely by a Parish Councillor, and there are many near misses as vehicles cross the priority Old Leicester Road traffic to access the King's Cliffe Road.

PCC Response - PCC visited the location and noted that there was previously a footpath of sorts from Wansford to the bend near the Public Right of Way. We will look to reinstate this section of path with road planings (or similar). We will also be investigating the frequency that the Wansford Quarter of Sulehay Woods will be closed and whether the most recent closure is a one off as this would determine whether the path is reinstated in its full length or just to the Wansford Quarter of Sulehay Woods.

Parish Council Response - The footpath was originally laid down by PCC using rolled road planings, but destroyed by GigaClear and others installing fibre optic communications cable. Any idea when the works might commence?

PCC Response - We don't currently have a date for the works, but we would expect these to be carried out this financial year. It would be whether the path reinstatement would be to the field currently locked, or reinstated round to the Public Right of Way (as previous).

Parish Council Response - Obviously, we would prefer it to be reinstated to the Public Right Of Way at the OPH corner as many people use this route to access the PRoW north to cross the A47 and to access the Sulehay Woods.

b) Provision of Litter Bin by the seat adjacent to the Church – PCC's deadline for completing the work has passed. The Parish Clerk will contact PCC to learn the expected delivery date.
